### Policies and Guidelines

Tuition is based on classes assigned for the entire school year, not on the number of lessons in a month. **Therefore, tuition may be paid in full in August or divided into 9 payments.** Payment #1 is due in August/September with your annual family registration fee of \$75. The remaining 8 payments are due the first week of each month beginning October 2018. The last payment is due in May 2019. **Tuition is due regardless of school vacations, or family trips.** Your child is welcome and encouraged to make up missed classes at their assigned level on any alternate days. Ask your child's teacher or administration.

**Late Fees:** Tuition will be considered late after the 10<sup>th</sup> of the month. There will be a \$25 late fee for payments after that date.

**Dress Code and Ballet Etiquette:** All students will come in uniform. **Girls:** black leotard and pink tights and pink ballet shoes. **Boys:** white leotard, or fitted white T-shirt, and either black or white shoes. Girl hair must be in a bun. If hair is short, please pull it back from the face and secure with barrettes. No leg warmers, sweatshirts, shorts or sweaters in class. Please do not wear jewelry to ballet class. No gum or food in class. The student may bring water. Please be on time for your class. Once the class has begun, the student may not enter without permission from the teacher. Anyone entering class more than 10 minutes late may observe the class, but not participate. Pre-Ballet, Creative Movement and Elementary I students may wear white ankle socks instead of tights. **Online payments:** Tuition payments can now be made online. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE Thomas Armour Youth Ballet, Inc., including its Releasees from any and all claims, demands, damages, actions, causes of action of any kind or nature whatsoever which may arise in the future any injury, including but not limited to the death of the participant or damage to the property, arising out of or relating to the event(s) caused or alleged to be caused in whole or in part by the negligence of the Program or otherwise.

EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release and waiver is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
  
6. On behalf of the Participant, the undersigned executes this Waiver and Release. If, despite this release, the Participant makes a claim against any of the Releasees, the undersigned will reimburse the Releasees for any money which they have paid to the Participant, or on his behalf, and hold them harmless.
